4. I want to emphasise respect, diversity and inclusiveness. We need to enhance mutual understanding and active participation of all our member bar associations and members. We want to listen from you. More dialogues and closer communication are much needed. This will

make LAWASIA stronger, more diverse and more relevant to all of us.

I would like to take this opportunity to acknowledge that none of this could be achieved without the support of the Secretary General, the Advisory Board, the Vice Presidents, and the Executive

Committee. I would also like to acknowledge the very small Secretariat staff of LAWASIA, who have

worked tirelessly to organise this conference today.

I would like to thank you all for your support of my term as president and for attending our first virtual

annual conference this week. I pledge to use my time as the President in pursuit of the aims of LAWASIA,

by recognising its history and working towards a future of greater collaboration across the region to

advance the rule of law and the protection of human rights.
