Name / Date of Activity	Details of activity
China Forum on International Legal Cooperation (2021)	On November 12 <sup>th</sup> , 2021, the China Forum on International Legal Cooperation (2021) was held in Beijing by China Law Society. With its theme of "The Innovation and Perfection of the Belt and Road International Economic and Trade Rules", the forum held extensive discussions on how to provide better legal protection for high-quality joint construction of Belt and Road Initiative. The Forum released the Beijing Declaration of the China Forum on International Legal Cooperation (2021).
China Forum on Rule of Law (2021)	China Forum on Rule of Law (2021) was held simultaneously in Beijing and Shenzhen on December 23 <sup>rd</sup> , 2021. With its theme of "Adhering to the Rule of Law in an All-round Way and Striving for the Construction of Rule of Law in China", the forum held extensive and forward-looking discussions on topics such as "Rule of Law Development in Guangdong, Hong Kong and Macao's Greater Bay Area in the Background of Rule of Law in China""Legal Protection for Construction of New Development Paradigm" "Theories and Practices for Construction of Model City of Rule of Law First".
The 15 <sup>th</sup> China Jurists Forum	The 15 <sup>th</sup> China Jurists Forum was held in Beijing on February 22 <sup>nd</sup> , 2022. With its theme of "The Concept and Construction of People's Democracy in the Whole Process", the Forum called for enhanced research and advocacy on the national and legal systems, promoting the establishment and improvement of the legal system as a response to demand both of national governance and people's better life.
Actively Promoting the Revision and Implementation of the Anti- Monopoly Law (2022)	In recent years, there have been frequent occurrences of monopoly acts in the platform economy. The Anti-monopoly Law (2022) further clarifies the law revision orientation of our country to regulate the anti-monopoly of platform economy and promote high-quality development of digital economy on the track of rule of law. China Law Society held an expert seminar on the legislation of the Anti-monopoly Law (Draft Amendment) on November 19 <sup>th</sup> , 2021. After the official implementation of the Anti-Monopoly Law (2022) on August 1 <sup>st</sup> , 2022, many law experts of China Law Society were

	invited to participate in the consultation and put forward suggestions
	for the government.
Other activities of legal research and exchange	Established in 2021, the Research Center of Xi Jinping Thought on the Rule of Law continues pushing forward research (both domestic and overseas), publicity and explanation of Xi Jinping Thouth on Rule of Law.  The "100 lectures by 100 jurists (2022)" was held on July 22 <sup>nd</sup> , 2022 by China Law Society, focusing on construction of socialist legal system with Chinese characteristics.  CLS continued to hold exchange and training programs for foreign legal talents, held two online training courses for foreign legal talents, respectively the 7 <sup>th</sup> China-South Asia Legal Training Course and the 9 <sup>th</sup> China-Africa Legal Training Course, in which CLS introduced China's legislative progress and China's experience in comprehensively promoting epidemic prevention and control on the track of rule of law.
