1. A brief summary of 4 key events and activities undertaken by our organization in the past 12 months.

| Started public platform service of 'My Lawyer' | Due to the influx of external capital and power into the legal market in addition to the development of IT technology, as private platforms for commercialization are popping up in Korea, various problems that hinder the public nature of lawyers and legal business have been raised. In order to proactively respond to these problems, protect the value of the legal profession, and provide accurate and transparent lawyer information to the public, we jointly developed a lawyer information center with the Korean Bar Association. Officially, we launched the legal platform service 'My Lawyer' in April 2022. Through our own platform, members can |
| | promote themselves free of charge without additional advertising or brokerage fees, and users can also easily access information about lawyers based on trust through the verification of the Bar Association. |
| Promotion of professional liability insurance | In order to ensure that members can work in a more stable work environment, the association took the initiative in setting up a professional liability insurance system. By taking out 'professional liability insurance' in the form of group insurance with our association as a policyholder and each practicing member as the insured, we accept applications from members who want insurance and support insurance free of charge. With compensation for damages to a third party pursuant to the lawyer's legal liability for damages and defending charge required for the decision as a coverage, the association supports insurance with the compensation limit of 100 million Korean Won(about 90,000 US dollars) per accident. |
